Brett Brownscombe, natural resources policy advisor for Governor Kitzhaber, has been invited to speak at the luncheon. After lunch, concurrent sessions will continue on **Sustaining Oregon's Forests in a Changing World** and **Intensive Forestry in Our Future**. The OSAF awards banquet will round out the day. Participants can choose between two field trips on Day 3. One trip will showcase the Northwest Forest Management Plan and how it is being implemented on the Clatsop State Forest to
